The John Hill School and the School Street School, and the parents of the students participating in activities, services and programs funded by Title 1, Part A of the Elementary and Secondary Education Act agree that this compact outlines how the parents, the entire schools staff and the students will share responsibility for improved student academic achievement and the means by which the schools and parents will build and develop a partnership that will help children achieve the State's high standards. School Responsibilities

The Boonton Public Schools (JHS and SSS) will:

- Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables participating students to meet the State's student academic achievement standards as follows:**

John Hill School and School Street School will provide an optimum educational experience for all students, creating a passion for learning and encouraging all students to perform to their highest academic potential while promoting self expression, cooperation and respect for others. This shall be accomplished via a seamless integration of the Common Core State Standards (CCSS) into the district curriculum, incorporating best teaching practices and technology into the fabric of the classroom environment. JHS and SSS will provide parents with assistance in understanding the CCSS and State assessments through parental involvement activities held throughout the course of the year. Through the combined efforts of staff, parents and students, an optimal and productive earning environment will be established through which students will achieve to their maximum potential.

- Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.**

During school/grade level orientation programs, Back to School Night, in our school weekly and monthly updates and in home/school communications parents are urged to contact the school office to arrange a meeting with the teacher whenever it is believed that a conference would be necessary or helpful. All staff members, including teachers, principals and nurse are available for conferences with parents upon request. Parent teacher conferences are also held on specific dates each year in the fall and in the spring. For 2016-2017 those dates are November 7 and 8, 2016 and March 6, 2017. At these times, parents may choose a day or evening appointment time to discuss their child's academic progress or concerns. If a parent is unable to meet during this time, teachers will reschedule the appointment for a more mutually agreeable time or suggest a phone conference.

The John Hill School and School Street School faculty and administrations encourage frequent meetings between parents and teachers, believing that this is the single most effective way to help students achieve their potential. Communication between home and school minimizes students' difficulties and enhances the quality of the education that can result from total mutual understanding.

- Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:

Students in Grades K-8 receive reports cards in November, January, April and June. Mid-marking period progress reports for students in grades 4-8 are sent home in October, December, March, and May. For students K-8, mid-marking period progress reports may be sent to parents if deemed necessary by the teacher. Current work and projects are also included in the schools' weekly updates that are emailed to parents and posted on the web site.

- Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:

If a parent would like to speak with a specific staff member, teachers are available for consultation before and after school or during a teacher's prep period at mutually agreeable times. In addition, parents may choose to contact a staff member by email or telephone to communicate their concerns. All teacher and administrator emails are posted on the school web sites and parent portal, Realtime.

- Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities,** as follows:

During the school year, various grade levels have opportunities for parents to observe student presentations, assist in arts and craft projects, visit the classroom as a guest lecturer during special programs, and invited to attend assembly programs. Additionally, a Showcase of Excellence is held each year where parents visit to see student work and exhibits, demonstrations and performances, and have the ability to discuss student work with teachers. During the annual Read Across America activities parents can volunteer to read to the elementary students. The PTA sponsors two book fairs a year and hosts several family events.

6. Provide academic support to both parents and children outside of the normal school day. In an effort to extend opportunities for both parents and children to strengthen academic skills in language arts and math, tutoring program for math and LAL skills fragile students, homework help, and adult literacy programs are available through local community organizations.
7. Involve parents in the planning, review and improvement of the school's Parental Involvement Policy, in an organized, ongoing, and timely way.
8. Involve parents in the joint development of any school-wide program plan, in an organized, ongoing and timely way.

Hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements, and the right of parents to be involved in Title I, Part A programs. For the 2016-2017 school year, the Title I Annual Meeting is scheduled on September 28, 2016. The school shall offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite to this meeting all parents of children participating in Title I, Part A program (participating students), and will encourage them to attend.

- Read at least 20 minutes every day outside of school time.
